Introduction

Respected Dr. Kaza, you are obviously a very accomplished individual and hold the honorable position of guiding the reputable Truth Labs for Forensic Studies. It is for this reason I am contacting you regarding the recently released Truth Lab “Salient Features”¹ Document. Therein your analysts have endorsed Dr. Morris’s Neutron Activation Analysis of extremely tiny portions of Bhaktivedanta Swami’s hair.

Are you aware of how he and other unscrupulous individuals are now exploiting your work as conclusive evidence that Bhaktivedanta Swami was maliciously poisoned by his senior disciples in 1977? Are you aware of the fact that a comprehensive study of *ALL the available evidence*, that extends far beyond Dr. Morris’s report, proves that nobody could have poisoned Srila Prabhupada as maliciously alleged! Allow me this opportunity to share with you a brief history of what your firm is getting dragged into.

Brief History of Poisoning Allegations

When young, idealistic men raised in Western culture first come in contact with the extraordinary Vedic teaching of your great Indian culture, many become enthralled by it and

immediately join the Hare Krishna ashram. However, being young, immature, and often very naive, some encountered personal difficulties in adapting to the strict principles of Ashrama life. ISKCON's liberal open-door policy at that time also attracted dysfunctional misfits as well as some who suffer from severe social disorders and mental illness.

Twenty years after Bhaktivedanta Swami departed, a rumor began that he was intentionally poisoned by his most trusted senior disciples. At first nobody took this wild allegation seriously.

Nico Kuyt is the person who started this ugly poison rumor. His behavior over the last 40 years confirms that he is a sociopathic narcissist, craving for attention and will do whatever he must to get it. In the early 70's Mr. Kuyt was an ISKCON temple president but due to his social illness, he grossly abused the privileges of his position and had to be removed. Consistent with a text book definition of a sociopath, Nico was unable to recognize that he was demoted due to his own serious predatory foibles. Salient features of the Forensic Evaluation & Interpretation of Neutron Activation Analysis NAA Reports of Dr. Morris on the Hair Samples of Srila Prabhupada), along with Pharmaco-Pathological and Medico-Legal Assessment Report of August 2024 of Truth Lab

Mr. Naveen Khurana submitted a requisition letter dated September 1, 2019, along with the certain documents to Truth Lab for Forensic Evaluation & Interpretation of Neutron Activation Analysis (NAA) Reports of Dr. Morris on the Hair Samples of Srila Prabhupada, Pharmaco-Pathological and Medico-Legal Assessment Report **on the cause and manner of death of Bhaktivedanta Swami Srila Prabhupada**, who passed away on 14th November, 1977.

- 1) It appears that Naveen Khurana contracted with Truth Labs on September 1, 2019 to provide a “scientific opinion.” He requested commentary on the 5X6 matrix Dr. Morris used to record the results of his NAA analysis on tiny hair samples, done on Nov. 23, 2015, at the Missouri University Research Reactor (MURR) lab. This document is dated August 2024. Is that the normal turn-around time for Truth Labs to provide an opinion on the metrics found on a simple matrix? Was Truth Labs reluctant to give a professional, “scientific opinion” based only on what Mr. Khurana had submitted for Stuey? It appears from the language and content found in this document, that after getting no results for a long time, Mr. Khurana complained about the delay so your lab finally got the work done so they could close the file on it. Why did it take five years for Truth Labs to complete a simple six page report?

Dr. Gandhi PC Kaza, Chairman and Founder of Truth Labs, an Independent Forensic Science Laboratory in India constituted an Experts' Committee for forensic evaluation and interpretation of the results of NAA analysis, and to carry out Pharmaco-Pathological and Medico-Legal assessment on the cause and manner of death of Srila Prabhupada, with the following members:

- a. Dr. Gandhi PC Kaza, Chairman and Senior Forensic Expert of Truth Labs, Hyderabad for Forensic Evaluation on NAA Reports,
- b. Dr. D. M. Ravichand, Professor & Consultant of Pharmaco-Pathology of Truth Labs, Hyderabad to examine the Pharmaco-Pathological aspects of the incident, and
- c. Dr. M. Narayana Reddy, Professor and Medico-Legal Consultant of Truth Labs & Professor of Forensic Medicine & Toxicology, Hyderabad to analyse the NAA and Pharmaco-Pathological reports along with background documents, to arrive at an opinion about the cause and manner of death of Swami Srila Prabhupada.

d.

NAA EVALUATION AND INTERPRETATION REPORT:

1. Based on the details of chain of custody of six hair samples (Q1', 'D', 'A', 'J', 'ND-2' and 'Q2) provided in the requisition letter as 'Annexure-P, the following facts were drawn:

- a. The ISKCON's Governing Body Commission (GBC) and other followers of Srila Prabhupada preserved the scalp hair as sacred relics.
- b. Dr. J. Steven Morris of University of Missouri at Columbia tested six of Srila Prabhupada's scalp hair samples preserved as sacred relics for NAA for the presence of arsenic (As), cadmium (Cd), antimony (Sb) and mercury (Hg). These samples were tested at different times in 1999, 2002 and 2005.
- c. The hair samples collected, 'J' and 'ND-2' were from the period before mid-1976, whereas the remaining four samples 'A', 'D', 'Q1' and 'Q2' were taken between Nov 1976-Sep 1977.



2 The results of NAA performed by Dr. J. Steven Morris at MURR are shown in Table-1 below: *NAL: Normal Average Level in ppm as stated by Dr. J. Steven Morris and the requisition authority.

3. Based on the above table, the following inferences are drawn:

- 2) Truth Labs clearly state how the conclusions provide about this paper are **“Based on the above table”** created by Dr. Morris Nov. 23, 2015 with the (MURR) NNA equipment.
- 3) You make no mention of the fact that analysis of hair contents will often provide much higher readings than that which is found in the blood stream because it is extremely absorbent and had many weeks to keep absorbing elements from the blood stream. When the exposure continues beyond a month, hair samples could show significantly higher cadmium concentrations than blood, potentially by several orders of magnitude depending on the exposure duration and intensity.
 - a. The test results indicate that the cadmium levels were abnormally high ranging between 177-284 time.
 - b. The above results clearly indicate the multiple times cut hair samples marked as 'A' and Q2' contained 177 times and 212 times higher levels of Cadmium, whereas the single cut sample marked as 'D' contained the highest quantity of Cadmium. The above variations in the hair samples strongly indicate that the single cut sample containing 284 times more cadmium levels is one of the highest levels of ingestion.
 - c. The NAA test results show that Srila Prabhupada was primarily poisoned with cadmium.
- 4) NO. This is very premature and misleading! This statement is based on the numbers reported by Dr. Morris but it does not take into consideration all the disclaimers he

issued when he issued this report to Nico Kuyt. Naveen Khurana has intentionally withheld that essential information from Truth Labs. His agenda was to get Truth Labs to issue a document with this conclusion so he can use it for his own nefarious reasons.

- 5) This matrix only provides the numbers reported by Dr. Morris and not all the disclaimers he also issued to prevent anyone from jumping to the conclusions like the one reported here by Truth Labs! Would your forensic experts assert *Srila Prabhupada was primarily poisoned with cadmium* after considering the following which was withheld from them?

Dr. Morris...

1. ...explained each element required different setting for optimum measurements.
2. ... tells us the reactor was set to detect arsenic, not cadmium.
3. ...tells us for cadmium, these parameters are not as favorable as they are for arsenic.
4. ...tells us he was "refining his testing techniques"
5. ...acknowledges the exceptionally small size of the samples.
- 6... states: "with cadmium we cannot detect a normal level in these small samples"
- 7 ... states the large uncertainty is the result of the small sample mass (0.00012 grams)
8. ... tells us he increased the neutron activation to more radiation than "normal"
9. ... admits he stumbled upon the cadmium readings.
10. ... reveals how his process for collecting gamma rays went on for 5 days.
11. ...reports that the vials used to hold the samples had a minute presence of cadmium.

It was later discovered that:

1. Collecting data for five days is evidence the DELAYED NAA process was used.
2. Cadmium is limited to a ten-minute gamma bounce off rate.
3. Therefore; the PROMPT NAA process is required to measure cadmium content.
4. Based on this it appears Dr. Morris has a lot more explaining to do.
5. Even arsenic requires the PROMP NAA process.
6. This raises a lot of questions over what Dr. Morris was actually doing and why?
7. This was the first time MURR equipment was used to analyze hair.
8. The samples Dr. Morris were given were 1/80th the normally required size.
9. The NAA process is lauded for analyzing samples without destroying them.
10. After the report was issued, Nico reports that the samples were destroyed!?
11. Dr. Morris was under a gag order to not communicate with anyone else about anything he did except exclusively with Nico Kuyt alone.
12. There has been no double testing or cross examination from other experts in NAA process about the methodology used by Dr. Morris.
13. In 1977 nobody had ever used cadmium to intentionally poison anyone because it was not even known back then how dangerous it was and thus completely unregulated.

14. A study done at John Hopkins University in 2013 (40 years later) reported: “We already know about the health hazards of heavy metals like lead and mercury, but we don't know much about what cadmium does to the body”

- 6) On August 2024, Truth Labs issued an Assessment Report where they state: “*The NAA test results show that Srila Prabhupada was primarily poisoned with cadmium.*” Naveen Khurana is now claiming that the Assessment Report issued by Truth Labs is “Scientific Proof” that A.C. Bhaktivedants Swami was intentionally murdered by his own disciples. This should be of great concern to Truth Labs because *when ALL the evidence is considered*, it clearly shows that nobody could have poisoned Srila Prabhupada the way Naveen Khurana has alleged for the last 20 years!

d. Arsenic, Antimony and Mercury appear to have been used in toxic doses occasionally.

e. Two scalp hair samples and 'ND-2' belonged to the period when Srila Prabhupada's health was near normal indicating the toxic ingestion could have been initiated after mid-1976, whereas the remaining four samples 'Q1', 'D', 'A' and 'Q2' belonged to the period when his health had rapidly deteriorated in the last stages of his life.

4. PHARMACO-PATHOLOGICAL ASSESSMENT REPORT:

Toxicity of Cadmium:

- a. Cadmium is a metabolic poison and when orally ingested, cadmium gets deposited in the kidneys and liver, and a minimal amount is excreted through urine. Cadmium causes renal tubular damage, leading to overall physical deterioration.
- 7) It also builds up in the bone and causes severe damage, none of which was evident in Srila Prabhupada's symptoms.
- b. Cadmium is a naturally occurring toxic heavy metal that interferes with the functioning of some of the basic chemical processes that sustain life.
- c. It is present in only trace amounts in the environment.
- 8) Although this is not an alarming statement, it can be considered misleading because cadmium is a naturally occurring heavy metal found in the Earth's crust, and human activities have significantly increased its prevalence in the environment. Its presence comes from both natural sources (like weathering of rocks and volcanic activity) and anthropogenic sources (human-made activities).
- d. Cadmium is a cumulative poison due to slow excretion from the body. About 10 mg of ingested cadmium causes severe toxic symptoms.
- e. Cadmium is carried through the blood and gets deposited in the hair, and the amount of cadmium deposited in the hair depends on the corresponding blood level at the time of deposition which varies with the poison ingestion time.
- 9) Hair analysis is more reflective of long-term exposure, while blood levels fluctuate and decrease as the body processes and excretes cadmium. However, chronic cadmium



exposure leads to much higher concentration readings in hair compared to blood due to the bioaccumulation effect.

f. Cadmium poisoning is irreversible. There is no antidote or chelation therapy for cadmium poisoning.

g. No G provided? (Is this evidence of sloppy proofreading?)

h. No H provided? (Is this evidence of sloppy proofreading?)

i. No I provided? (Is this evidence of sloppy proofreading?)

j. Ayurvedic drugs do not contain cadmium.

k. The possibility of cadmium contamination interfering with the presence of cadmium in hair samples is remote as the MSDS data of Wahl Clipper oil which only contains white mineral oil with no chance for the presence of cadmium or any other metallic toxic components. The possibility of cadmium contamination in body massage oils is ruled out as per the data given for organic oil compositions of natural organic medicines extracted from medicinal plants marketed as ayurvedic drugs, only contain organic essential oils with no chance for the presence of cadmium or any other metallic toxic component.

10) Hair is so absorbent it is stitched together into large matts and used to absorb pollutants in the ocean. Smokers know they must thoroughly wash their hair if they do not want to smell like burnt cigarettes. The Wahl hair clippers are plated in cadmium to increase corrosion resistance, and lubricity. The tiny hair given to Dr. Morris for testing was extracted from behind the plated clippers where it had sat for over 25 years. Although Nico goes to great extent to convince his audience that external contamination of the samples was NOT possible, Dr. Morris himself cautioned: “Do Not Rule Out External Contamination”


Dr. Morris detailed his work:

“As we have discussed previously, with such small samples the so-called analytical blank must be carefully determined so that one does not assign analytical signal to the sample that is actually associated with some other source. In this case there are two possibilities that could confound the hair analyses: external contamination and impurities in the small vials used to contain the hair specimens during the neutron activation analysis.

“External contamination cannot be completely ruled out without a detailed history of the sample; but one can search for possible sources of external contamination. In the instant case: I now have checked the containers the samples have been stored in and find no evidence of significant contamination sources for arsenic, cadmium, antimony, or mercury.

“I also carefully analyzed the high-purity vials (blanks) that I use in the NAA experiments and as expected there is a minute presence of the elements of interest in these vials. Keep in mind insofar as trace elements are concerned there is “everything in everything” if one has a technique sensitive enough to make the measurement. I have now made these sensitive measurements and have “blank-corrected” the results...”



5. Cause of death appears to be intricately linked with Cadmium Poisoning.

11) The use of the word “appears” makes this a less damning and more sober statement but it would be much clearer if it was worded:

“Based on a simple initial overview of the numbers provided in the matrix Truth Labs was asked to evaluate, the cause of death might have been complicated by the ingestion of heavy metals.”

a. The abnormally high levels of cadmium found in Swami Prabhupada's hair relic samples to the extent of 284 times beyond normal human threshold limits must have led to endothelium damage that *appears* to have caused both cardio-toxicity and neurotoxicity, resulting in slow deterioration to death.

- 12) When 284 times the threshold of cadmium exposure is reported, the first thing a good forensic investigator would ask is: "Has this number been confirmed by an outside neutral third party?" The answer to that NO!
- 13) To be sure that nobody could double check Dr. Morris's work, Nico tells us the hair samples that were tested got destroyed during the testing! But the NAA analysis is lauded for it's ability to test substances without destroying the sample!
- 14) Apparently, nobody had enough common sense to even ask: How would it be possible for anyone to ingest such exorbitant amounts of cadmium and then still live long enough for their hair to grow out long enough to be cut and tested? Occam's Razor brings us back to Dr. Morris's simple explanation for the abnormally high reading: "Do not rule out external contamination." But agenda driven Naveen Khurana intentionally withheld all this information from Truth Labs knowing that without having it, they would provide him with the documents he needed to keep the poison conspiracy alive!

b. From a Pharmaco-Pathological point of view, it is further inferred that Srila Prabhupada *appears* to have been given food admixed metallic poisons intermittently, the primary toxin being cadmium, which *appears* to be the root cause of cadmium ingestion orally that led to his death.

- 15) Here it is appreciated that Truth Labs strategically uses the word "appears" several times in this document as they scrutinize the facts and remain cautious about coming to a accusatory conclusion that Srila Prabhupada was intentionally given cadmium to cause his death.

6. MEDICO-LEGAL ASSESSMENT OF THE FACTS INCLUDING NAA REPORTS:

6.1 Cadmium chloride can easily be administered through food, drink, or medicine without arousing any suspicion.

Evidence that this is simply not true can be quickly understood in a case where David Xu attempted to poison his coworker using cadmium. We learn from this video how the victim immediately tasted the cadmium, and when she went to the hospital after the 2nd attempt, a simple nurse was able to identify that the poisoning agent was cadmium!

6.3 Cadmium is easily accessible in the chemistry laboratories of high schools and colleges, or from local grocery stores as pesticides.


- 16) There is never a coherent attempt to explain how a full time temple devotee, always surrounded by other devotees, had the time to acquire cadmium, understand where to get it, how to handle it, where to hide it and, most importantly, mix it and administer it perfectly without flaw on the first occasion? How could someone with absolutely NO

experience in chemistry create the exact doses to get the perfect results where not too much is given, causing immediate nauseous reactions, but not too little is given and thus rendering the whole conspiracy effort unsuccessful?



6.4 Evidence of NAA analysis reveals slow poisoning with heavy metals, primarily the cadmium, the effects of which mimic the symptoms of diabetes and kidney disease thus not arousing the suspicion of poisoning, especially when administered in low dosages for about 18 months, combined with heavy doses intermittently.

17) This paragraph sounds like it was dictated to Truth Labs right out of Nico's Kill Guru, Become Guru diatribe originally first published (2017). We have already exposed all the problems involved in blindly accepting Dr. Morris's work without the results being duplicated by a second impartial NAA lab. We have also illustrated just above how fantastic it would be to expect anyone to mix, and administer a closet brewed concoction of cadmium to get the perfected performance results that are implied here.

6.5 Cadmium and Arsenic are "masquerade" poisons which are not detectable in routine tests. Chronic cadmium or arsenic poisoning cause physiological conditions which are typical of old age and, therefore, arouse little or no suspicion and the condition of the patient is similar to that of a person suffering with chronic starvation.

18) The telltale evidence of cadmium poisoning is severe bone damage, and the increased risk of cancers, particularly lung, prostate, and kidney cancer. Srila Prabhupada had NONE of these symptoms. Those promoting this ugly rumor are so desperate to get others to believe it they even falsely claimed that photophobia is a symptom of cadmium poisoning despite the fact that it is not listed anywhere as such. This is a good example of the many unfounded claims which they created simply because Srila Prabhupada wore sunglasses toward the very end of his life. The perpetrator of this misinformation knew many would simply believe it without seeing if it had any merit.

6.6 The NAA hair tests and medical history of Srila Prabhupada show that the poisoning was chronic for about 18 months.

19) There was absolutely no chain of custody on the hair samples with absurd contamination reading (D, A, Q-2). Those samples passed through the hands of seven different individuals over the course of 25 years, while changing containers several times and traveling all over the world and finally to Dr. Morris's lab in Missouri, USA. This type of evidence is so unreliable that no legitimate court in the world would consider it as admissible evidence because it could have been so easily contaminated.

6.7 Srila Prabhupada's poisoners would necessarily have been close attendants to the victim to administer the periodic doses of cadmium. A trusted servant would be the only one with access to carry out a clandestine tainting of food or drink with poison, which Srila Prabhupada ingested without any suspicion.

20) Srila Prabhupada and all his leading disciples were never left alone. They lived in the ashram, ate together, shared showers, and attended devotional practices all day long with each other. As his health declined, his eating virtually stopped, which led to extreme weight loss. On the rare occasions when Srila Prabhupada occasionally did eat, the little that was left on his plate was immediately distributed as prasadam to his disciples. None of them experienced ill effects. What is obvious by its absence, is any credible explanation how someone could have given poison considering the environmental layers they would have had to surreptitiously penetrate without ever getting caught... for 18 months!

6.8 Because it was not a one-time poisoning, the hair tests and history of the physical symptoms showing that cadmium was ingested from as early as May 1976 up to November 1977, or 18 months, namely in a chronic manner, the poisoners would need regular access to Srila Prabhupada, and that would rule out any outsiders.

21) The conditions explained above expose the absurdity of this assumption. Those making this accusation can only speculate about WHO committed this crime as they have no court-worthy evidence or even a reasonable explanation how they might have done it! Who had the opportunity to purchase pesticides and hide it in the ashrama with nobody noticing? How did they even know cadmium was a poisoning agent when not one of the world health organizations listed it as such in 1977? Where did they get adequate knowledge of chemistry to know how to properly mix and administer a concocted brew of cadmium with clock-work accuracy? Administering too much would result in acute poisoning, but Srila Prabhupada was eating so infrequently that how could the logistics required to poison him as alleged ever be coordinated. All of this would have to be done while there was a steady stream of doctors coming with the hope of restoring Srila Prabhupada's health?

6.9 The type of poisoning that Srila Prabhupada endured narrowed the possible identity of the poisoners to those who were regularly staying around Srila Prabhupada, especially after the severe February, 1977 health decline.

22) Hospice workers assisting individuals with end of life organ failure have mapped this particular death trajectory. Srila Prabhupada had already lived nine years longer than his demographic group for elder men in Bengal. He had already experienced heart attacks while crossing the ocean twelve years earlier and that was the first sign his organs were starting to fail. To support his Poison Rumor, Nico misleads the innocent into believing the intermittent declines in his health is evidence of poison being



intermittently given. But that is another example of Nico's intentional malicious DECEPTION in an attempt to create evidence for something that never happened!

6.10 Cadmium would produce health debilitation slowly, and that would include starvation syndrome, which is found in Srila Prabhupada's health history in 1976-1977. Small doses of poisoning result in malaise, increased weakness, and a reduction in the body's general strength. The first significant dose appears to have been administered on 20th July 1976, when Srila Prabhupada became extremely ill, and then again on 26th February 1977, coinciding with the serious health crises of Srila Prabhupada.

23) This is a nonsense attempt to interpreting the normal end of life organ failure trajectory as "Evidence" of periodic poisoning.



6.11 Srila Prabhupada's health profile with signs and symptoms are fully compatible with cadmium poisoning.

24) Srila Prabhupada's declining health trajectory is ALSO fully compatible with someone who had diabetes, lived nine years beyond his life expectancy, suffered several heart attacks and eventually collapsed as all of his organs began to fail.

6.12 A sprinkle of colourless, tasteless, and odourless cadmium powder would go unnoticed and could produce a severe downturn in health. Cadmium is potently poisonous.

25) This is a fabricated lie Nico came up with to explain why Srila Prabhupada's extraordinary taste buds could not detect the bitter taste of cadmium. It is a mystifying why Truth Labs published this without first researching to see if it was true. Had they done that they would have discovered that cadmium chloride has a bitter and astringent taste typical of many cadmium compounds. This has been determined via chemical analysis, human exposure, and many documented cases where it has been ingested. It is well-established that cadmium is not tasteless and can impart a distinct bitter or metallic sensation.

6.13 The nature and progressive history of Srila Prabhupada's declining health in his last year, with ups and downs and plateau periods, and sudden onsets of worsening, suggests a scenario of a steady use of "maintenance" poisoning punctuated by periodic and more intense doses. This comprises a mixed regimen of mid-level chronic, more acute poisoning and slow poisoning.

26) As evident by the notes provided all along, it appears that Truth Labs have been manipulated by Mr. Naveen Khurana into endorsing an intentionally convoluted



explanation for Srila Prabhupadas progressive failure of health. Mr. Khurana’s agenda is to gain creditability for rumors started by a very disturbed individual over 20 years ago (Nico Kuyt²) that recent facts have proven could not have possibly happened.

27) Tinged by his own prejudicial bias, Mr, Khuran has carefully presented Truthlabs piecemeal information that has never been cross examined or confirmed by a neutral third party. When all the collaborating evidence related to the poisoning allegations are objectively reviewed by an impartial audience, it indicates that nobody could have possibly poisoned HD Grace as has been maliciously alleged.

6.14 The constant anaemia, lack of appetite, no taste for food, and muscle weakness that is chronicled in Srila Prabhupada's health history was a result of a continuous episode of chronic poisoning, enough to produce effects of "starvation symptoms".

28) Concluding that these health symptoms are "...a result of a continuous episode of chronic poisoning," appears to be a poorly researched rush to judgement that can easily be attributed to many other medical maladies and does not include the most telltale signs of cadmium ingestion ie: bone deterioration. Was Mr, Khuran exerting pressure on your analysts to get a report out after sitting on it for five years?

6.15 Srila Prabhupada gradually lost weight and became progressively weaker, primarily due to his inability to eat or digest food and had no taste or appetite as cadmium is a craving poison which appears to have exhibited towards his end stage of life.

The cumulative considerations of all the above aspects indicate the cause of death to be due to homicidal poisoning by cadmium.

29) These follow up conclusions raise a lot of questions pertaining to the acclaimed expertise of Truth Labs. We have already explained how Srila Prabhupada lost weight, got weaker and could hardly eat because his liver and kidneys were giving out. Cadmium is not considered a craving poison because it does not have addictive properties or create a compulsive desire for repeated use, unlike substances such as nicotine, alcohol, or opioids.

30) The conclusions expressed here again raise serious questions about the integrity and competence of Truth Labs. These slanderous accusations expose those who have issued them to liability for sloppy, premature, false accusations.

6.16 Srila Prabhupada's hair tests indicate sustained high-level ingestion for about 18 months. ***It is virtually impossible to accumulate such levels from a normal environment*** of soil, air, water, food, consumer products, massage oils, hair clipper oil, or ayurvedic medicines.

31) Here the Truth Labs state: "It is virtually impossible to accumulate such levels from a normal environment" However it is very presumptive to conclude that the hair samples that sat untouched in a cadmium plated hair clipper for 25 years was preserved in a "Normal" environment. Hair is extremely absorbent and can be affected by the most innocuous environmental changes. Nico did an experiment using his own hair that exposes the futility of this statement. He reported that after he sanded window frames painted with old lead based paint, he sent his own hair in for testing and:

"...sure enough, the lead was quite elevated..."-KGBG 219

32) If we accept that Dr. Morris's NAA readings are 100% reliably accurate, which without additional testing by a third party is not a safe assumption, Occam's Razor dictates that the next most likely thing to be investigated is the very real possibility that the hair samples were contaminated. Especially because Dr. Morris specifically said: "Do not rule out external contamination." All those who continue to promote the poison rumor just ignore this disclaimer including Naveen Khurana. Now that this critical piece of information has been presented to the Truth Labs will they re-consider the prudence expressed in the above statement?

6.17 *It is impossible to scientifically explain* Srila Prabhupada's levels of cadmium as the result of accidental exposure to the above listed sources or tainted consumer products. Hence, this cannot be a case of chronic Accidental Death due to Cadmium Poisoning.

33) After providing the missing information that Naveen Khurana intentionally withheld are the analysts at the Truth Labs prepared to fully defend their statement that starts with... "*It is impossible to scientifically explain...*" to a jury of their peers?

7. OPINION OF THE EXPERT COMMITTEE:

7.1 The members of the Experts' Committee, have been of the opinion that the cause and manner of death of Srila Prabhupada was the result of a well-planned homicide by using the toxic metallic poisons, mainly cadmium and interspersed death arsenic and antimony, without arousing any suspicion, that caused the resultant signs and symptoms mimicking that of natural chronic illness.

34) This conclusive statement is worded as if it came right from Nico's original massive Poison Conspiracy campaign. I have taken the time to inform Truth Labs why I believe it would be prudent for them to carefully rethink the absolute conclusions expressed in their formal Salient Features report.

35) Hopefully the professionals who participated in authoring this document will realize it would be wise to rethink their published conclusions, especially now that you know how you have been played and your work is being exploited.

36) It is worth noting here that on 16th November 2004 individuals obsessed with the Poison Conspiracy fraud like Naveen Khurana filed a Writ Petition at High Court in Allahabad alleging that the ISKCON Governing Body Commission poisoned His Divine Grace. In their complaint, they presented the same defunct so-called evidence that continues to be used to keep this rumor alive still today.

37) After filing of this case, the plaintiffs were very excited and raved on about how they were "getting justice for the crimes committed" and how their efforts would "also act to clear Srila Prabhupada's name since he was not encouraging criminals, he was the victim of criminals."

38) By the spring of 2005 the prevailing justices threw the entire case out because there was no court-worthy evidence to support any of their accusations. It was found that the only thing behind the reckless allegations were hearsay rumors, manufactured conspiracy theories and absolutely no credible evidence. They ruled there was no substantial proof to support any aspect of poisoning allegations and it all ended with an uneventful thud with no legal actions taken against anyone!


